

## New Member Process and Application

*Applicants for new membership into Indiana Artists must meet certain requirements, have their artwork juried by a panel of IN/A members, and pay an initial application fee.*

### Requirements for Application:

1. Applicant must have been born in Indiana or lived in Indiana for the past two years.
2. Submit three original works of art, gallery-ready, created within the past three years, for juried review.
3. Submit a current resume and the application form (page 2).
4. Submit exhibition history: applicant's work must have been accepted into three different approved juried exhibitions and verified with enclosed catalogs, or copies of the catalogs from the exhibitions, or copies of juried acceptance letters/notifications.

Exceptions will be made on a case-by-case basis depending on applicant's professional status, out-of-state experience and/or media limitations. Contact the New Member chairperson with questions.

5. When you have your materials ready (including artwork) contact the New Member Chair for location, date and time for delivery of your artwork/materials for the upcoming review. New membership review will take place twice a year, in May and October.
6. Upon being notified of your approval, you will be billed an application/new member fee of \$50. The following year, annual dues are collected starting in January and are \$35 per year if paid by March 31. Dues increase to \$40 on April 1.

IN/A seeks applicants with a body of work that is consistent in style and media. In choosing your artwork to submit, please note the jurying criteria:

- Composition
- Use of color
- Originality
- Technical use of medium
- Consistency of style
- Presentation (clean mats, undamaged frames, etc.)

*Giclee' reproductions or enhanced giclee's are NOT acceptable as original work.*
