Digital reproductions, jewelry, functional ceramics, installations or videos will not be accepted.

Jurying for awards will be done from digital images submitted to the Exhibition Co-Chair.

### Eligibility/Images/Regulations

#### **Please read this carefully!**

- Accepted and delivered artwork to the exhibition must be the same image as that selected by the juror - no substitutions. Works may be for sale or NFS (not for sale).

- No works produced under an instructor/tutor will be permitted and must have been completed in the last two years.
- All work must be the artist's original design and creation. Copies of other artist's work or published photographs will not be accepted. Do not submit works that violate copyright laws, are computer generated or not of your own initiation.**
- No work previously shown in any Marion County competitive juried exhibition will be accepted.
- Artwork with frame is limited to 32x32 inches in any direction – INCLUDING FRAME.
- The winning artwork must be ready to hang upon delivery or it will not be accepted. Paintings must be in a gallery-quality frame.** Unframed canvas accepted if the wrap-around sides are finished. All paintings **must** have wires (no eye-rings or flat or saw-toothed hangers). **Acrylic (plexi) is preferred on works on paper.** Pastels may be framed with glass but must be in wood frames, not metal.
- No work may be removed from the exhibit prior to the pick up day.**
- Consent to photograph artworks for catalog/publicity purpose is hereby granted by entrant.

All reasonable care will be used in handling artwork; however, each entrant agrees to hold harmless Indiana Artists Club, The Brown County Art Gallery, their agents, officers and their representatives from any and all claims of damage.

The appropriateness of any work in the exhibition will be left to the discretion of the IN/A and the Brown County Art Gallery.

Work cannot be shipped to the gallery so please make arrangements to deliver your work if you cannot deliver your piece in person. No work may be delivered to the gallery ahead of time.

A commission of 30% will be charged on sales at the exhibition. The Brown County Art Gallery will collect the artist’s price plus sales tax. A check will be sent to the artist less the 30% commission.

The winning artwork must be picked up at The Brown County Art Gallery on Saturday Sept. 28 between 10:00 am and 2:00 pm or Sunday, Sept. 29, 2024, between 12:00 and 2:00 pm.
